Res. Sir/Madam,

This is with reference to your proposal for continuation of affiliation with vide letter no 01 to the University and as per vide reference letter no 02, Local Inspection Committee was constituted to visit the college and to submit the report.

The said Local Inspection Committee visited your college & thereafter submitted report to the University. The Board of Deans have scrutinized/verified the information submitted by Local Inspection Committee & on behalf of Academic Council Hon. Vice Chancellor has granted approval for Continuation of Affiliation/Natural Growth/ Students Admission to the subject/courses for the period shown in the Table.

In this regard the proposal for continuation of affiliation/ natural growth is approved to the subject/ course as per the Maharashtra Public University Act 2016, vide clause 114(1).

As per NCTE Norms & Standards 2014, fulfillment of conditions and approval concerned authorities will be mandatory.

The continuation of affiliation is granted to your college only for one year that is academic year 2025-26. The renewal of affiliation will be mandatory from time to time.

You are also informed that as per Section 108, Maharashtra Public University Act 2016, it is mandatory for you to fulfill the conditions suggested by the University for Affiliation and accordingly you are requested to fulfill the mentioned conditions in respect of your college within 03 months. However, preferably before submitting the proposals of Affiliation for A.Y. 2026-27 with the compliance report along with necessary documents to the University's Affiliation Section. If you do not fulfill the conditions, no proposals for the affiliation of academic year 2026-27 will be accepted by the university. Kindly note that you will be solely responsible for the same.

Though the college doesn't fulfill the criterion in regard with the full time post of Principal, Librarian and Physical Director and only fulfills the criteria of 50% faculty, the student's admissions are granted subject to fill the post of Principal, Librarian, Physical Director. In case the college fails to fill the posts, student admission will not be permitted & college will be considered "No Admission" for the academic year 2025-26.

However, the colleges which are notified as 'No Admission' in the table are approved only the continuation of affiliation/ natural growth for the academic year 2025-26. Such colleges should not admit the students for the first year and directly second year. The undertaking is to be provided by the Institution on

non-judicial stamp paper of Rs 500/- in regard with the fulfillment of the condition the post of Principal, Librarian, Physical Director, and 50% faculty recruitment and the recommendations of Local Inspection Committee with enough efforts are made by the college. If such proposal is submitted to the University the students admission will be considered. But the college will only admit the students after final approval of the university.

In case of colleges having the pending Court Cases, proper action will be taken subject to the order of the Hon.Court.

It will be mandatory for the college to complete the process of NAAC/NBA.

You are requested to take necessary action about the same and inform about the same to the University.
